### **NOTIFICATION - I**

No. UDD 325 MLR 2011, Bangalore, Dated: 10th December, 2012

Where as the draft rules, further to amend the Karnataka Municipal Corporations (Election) Rules, 1979, which the Government of Karnataka proposes to make in exercise of the powers conferred by sub-section (1) of section 421 read with section 55 of the Karnataka Municipal Corporation Act, 1979 (Karnataka Act 14 of 1977), was published as required by sub-section(1) of section 421 of the said Act, vide Notification No. UDD/325/MLR/2011 dated 18<sup>th</sup> October 2012. In Part-IVA, No. 765 of the Karnataka Extraordinary Gazette dated 19.10.2012 inviting objections and suggestions from all the persons likely to be affected within thirty days from the date of publication of the said notification in the Official Gazette.

And whereas the said gazette was made available to the public on 19th October 2012.

And whereas no objections and suggestions were received within the stipulated period.

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 421 read with section 55 of the Karnataka Municipal Corporation Act, 1979 (Karnataka Act 14 of 1977), the Governor of Karnataka hereby makes the following rules namely.

### RULES

- 1. **Title and commencement**.- (1) These rules may be called the Karnataka Municipal Corporations (Election) (Amendment) Rules, 2012.
  - (2) They shall come into force from the date of their publication in the official Gazette.
- **2. Amendment of rule 12.** In the Karnataka Municipal Corporation (Election) Rules 1979,(hereinafter referred to as the said rules) in rule 12, for sub-rule (1), the following shall be substituted, namely:-
- "(1) On or before the date appointed under rule 10 for making nominations, each candidate shall either in person or by his proposer, between the hours of Eleven 'O' clock in the forenoon and Three 'O' clock in the afternoon, deliver to the Retuning Officer at the place specified in this behalf in the public notice referred in rule 10, a nomination paper duly completed in Form 2 along with his

recent passport size photograph and nomination papers signed by the candidate and by six electors of the ward as proposers:

Provided that a candidate setup by a recognized political party shall be deemed to be duly nominated for election from a ward of the nomination paper is subscribed by one proposer being elector of the ward:

Provided further that no nomination paper shall be delivered to the returning officer on a day which is a public holiday."

**3. Substitution of Form-2.**- In the said rules, for Form-2, the following shall substituted, namely:-
